Nick also previously served as trial counsel for the U.S. Army at JBLM, WA; trial defense counsel for the U.S. Army Trial Defense Services, Ft. Bliss, TX and Bagdad, Iraq; and legal assistance attorney/tax officer for the U.S. Army Air Defense Artillery Center, Ft. Bliss, TX.

Nick earned his J.D. from Harvard Law School and his B.A. in political science from Morehouse College, *magna cum laude*.

Nick was appointed by Governor Inslee in 2013 to the Washington State Public Records Review (Sunshine) Committee and to the Washington State Statute Law Committee, and in 2016 to the Washington State Body Worn Camera Taskforce. Nick is active in the community, serving on the board of directors for Treehouse and previously as a member of Seattle Works. He also is a member of the Washington State Bar Association's Leadership Institute, the Federal Bar Association and the Loren Miller Bar Association.
