Meha brings a strong public interest background to her legal practice. Before joining Pacifica, Meha was an Assistant Attorney General at the Washington State Office of the Attorney General. There, she advised the largest state agency in Washington on matters related to vulnerable adult protection and long-term care regulation and defended the agency in the state administrative courts, state trial and appellate courts, and federal district courts. After law school, Meha served as a law clerk to the Honorable Linda Lee of the Washington State Court of Appeals, Division II.

Meha maintains a robust pro bono practice. Recently, she helped a woman from Afghanistan gain asylum in the United States. She has also represented an asylum seeker from El Salvador in immigration court, assisted two clients prepare applications for U visas, and helped minor children detained at the border to reunite with their family members in the United States. At the time that the United States pulled its military out of Afghanistan, she helped clients apply for humanitarian parole for their family members in Afghanistan. Additionally, Meha helped secure a remand for an Army veteran, who was denied VA benefits, before the U.S. Court of Appeals for Veterans Claims. She has also prepared a petition for clemency for a client detained in state prison.
