President Biden in 2021 appointed Nick to serve as the United States Attorney for the Western District of Washington, a position he held until June 2023. In that role Nick oversaw the Department of Justice operations for the entire district, including both civil and criminal matters. From 2013-2017, he was General Counsel to the Governor of Washington, advising on an array of legal issues, including high-priority litigation, criminal justice policy, tribal gaming and Indian law, and clemency petitions. He also managed the Governor's judicial appointments, including the appointment of 52 judges.

Prior to that, Nick served as Assistant U.S. Attorney in the U.S. Attorney's Office, Western District of Washington, where he was responsible for the management of a variety of federal criminal cases, from initial investigation to trial and sentencing, and through the appellate process. In that role, Nick appeared before every federal judge in the Western District of Washington and prosecuted over 100 individual cases.

Nick also previously served as trial counsel for the U.S. Army at JBLM, WA, trial defense counsel for the U.S. Army Trial Defense Services, Ft. Bliss, TX and Bagdad, Iraq, and legal assistance attorney/tax officer for the U.S. Army Air Defense Artillery Center, Ft. Bliss, TX.
